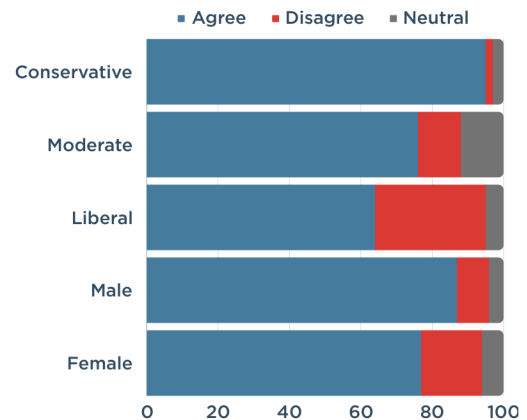
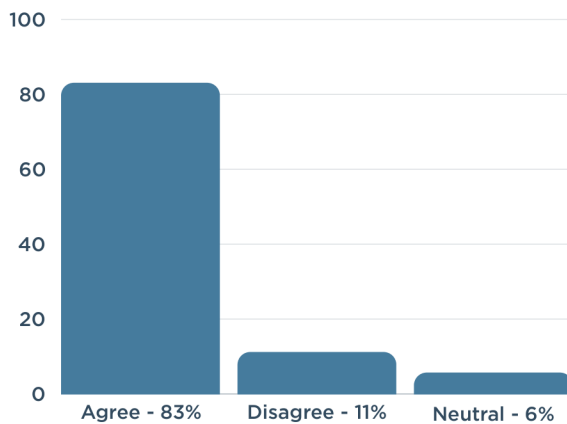


# IDAHO FAMILY POLICY POLL

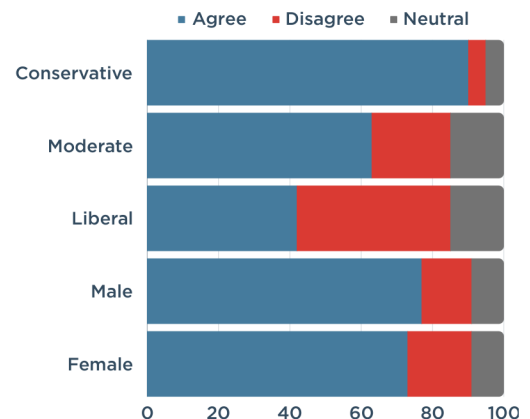
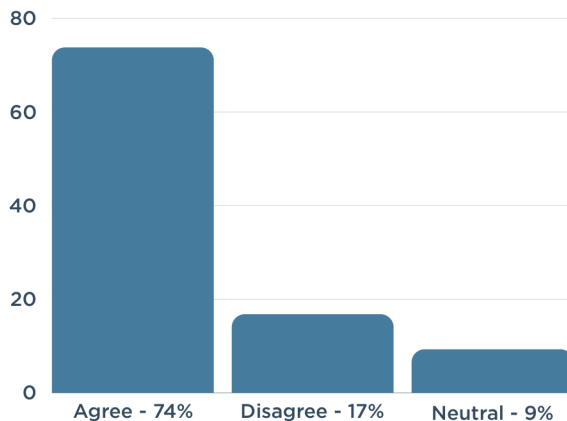

The “Idaho Family Policy Poll” was conducted from November 14-21, 2023, using interactive voice response (IVR) technology with calls made to a mix of both mobile and landline phone numbers. Respondents were randomly selected from a sample of likely voters, defined as voters who had voted in at least two of the previous four general elections. Quotas were used to ensure a geographically representative sample. Results include 411 completed surveys, representing a margin of error of 4.8% and a confidence interval of 95%.

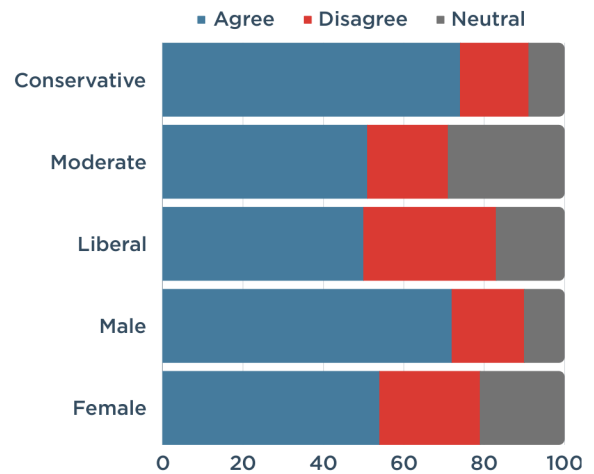
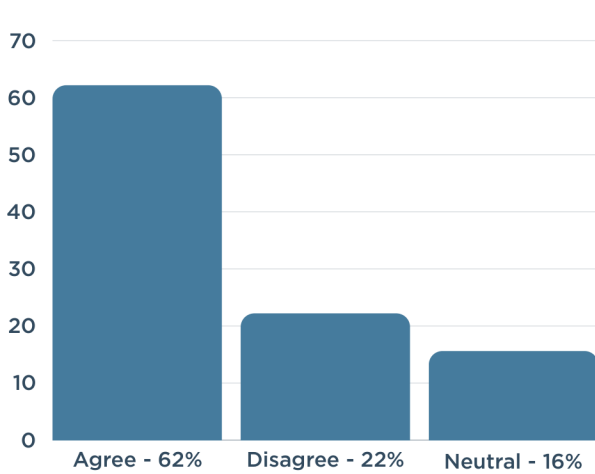
## 1. Do you agree with the following statement: “Schools should not withhold information relevant to a child’s physical, emotional, or mental health from their parent?”



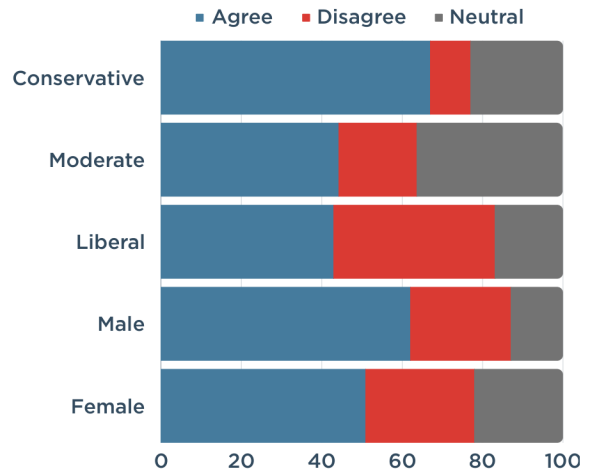
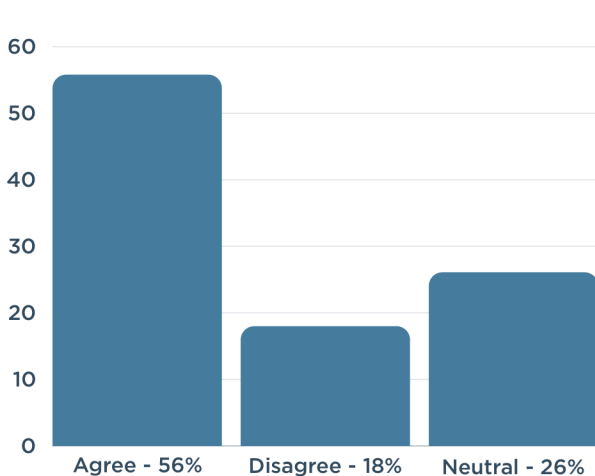
## 2. Do you agree with the following statement: “Schools should allow parents to review all curriculum and teacher training material for each of their children’s classes?”



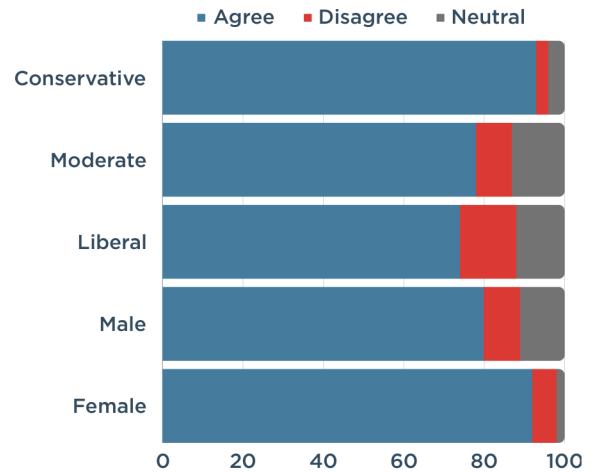
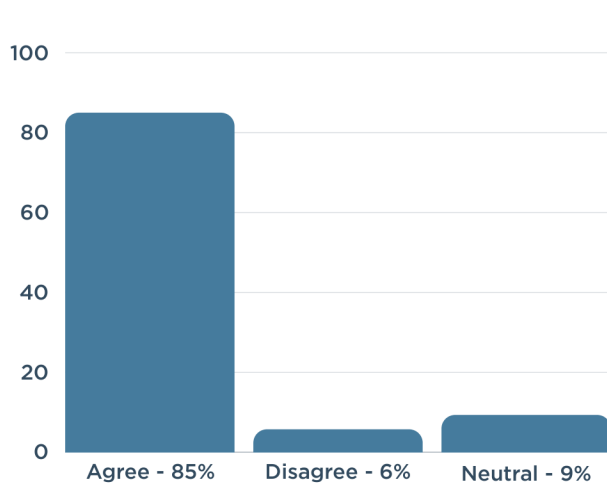
3. Do you agree with the following statement: “Idaho law should protect public school teachers who use biologically accurate pronouns to refer to students?”



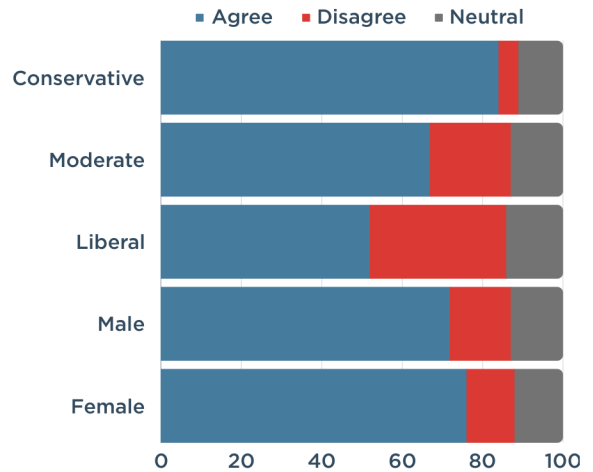
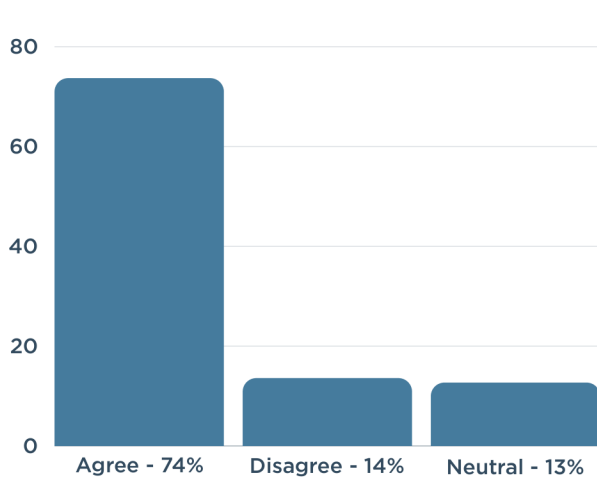

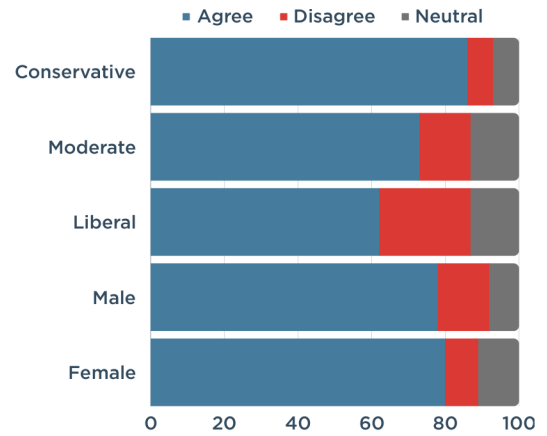
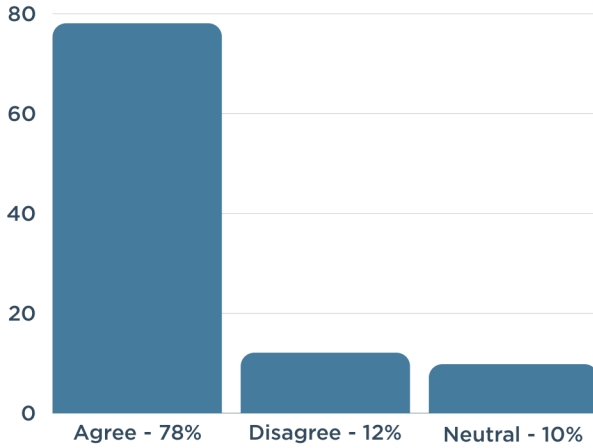
5. Do you agree with the following statement: “Pornography websites should verify that a user is an adult over the age of eighteen before granting the user access to pornographic content.”



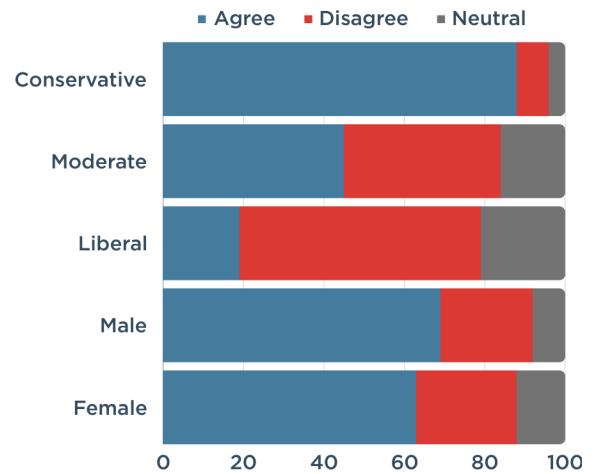
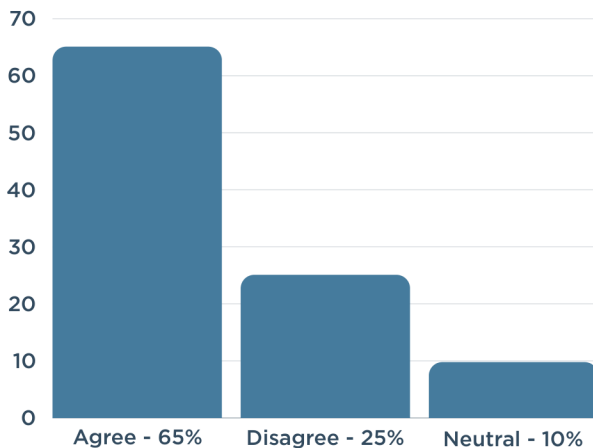
6. Do you agree with the following statement: “The Idaho Legislature should do more to combat human sex trafficking by increasing criminal penalties for prostitution?”



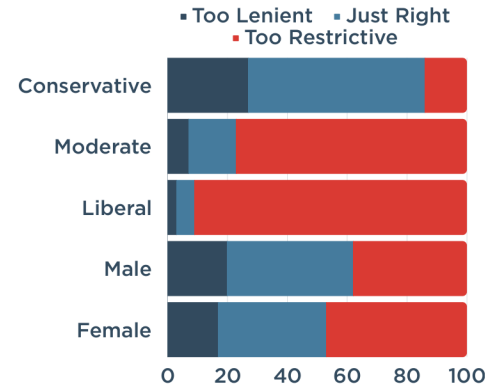
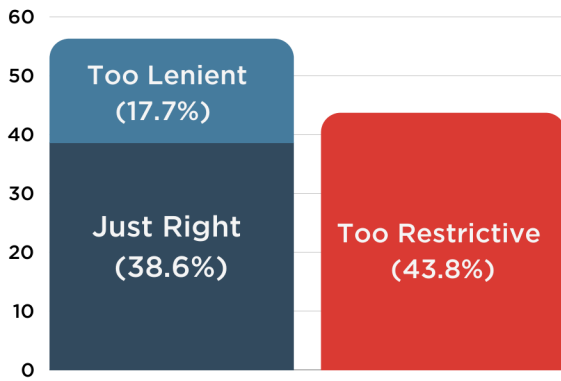
7. Do you agree with the following statement: “The Idaho Legislature should adopt mandatory minimum prison sentencing for fentanyl drug dealers?”
