



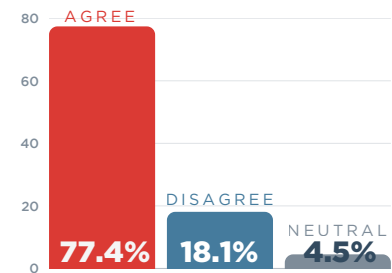
# IDAHO FAMILY POLICY POLL

## — 2026 —

The “Idaho Family Policy Poll” was conducted from Nov. 20–26, 2025 and Nov. 30–Dec. 2, 2025. The poll used interactive voice response (IVR) technology with calls made to a mix of mobile and landline phone numbers, supplemented by a text-to-web panel for additional completions. Respondents were randomly selected from a sample of likely voters, defined as registered voters who self-identified as “very” or “somewhat” likely to vote in the next general election. Results include those who expressed an opinion from 458 completed surveys, representing a margin of error of  $\pm 4.58\%$  and a confidence interval of 95%.

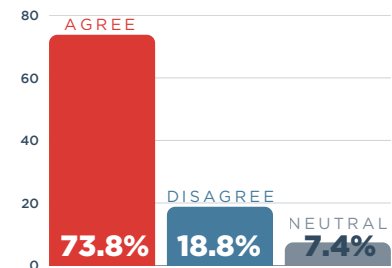
### Maintaining Separate Public Restrooms on the Basis of Biological Sex

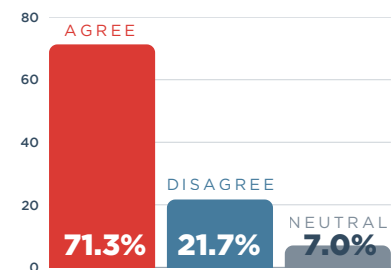
### Imposing Criminal Penalties on Men for Using Girls' Restrooms and Locker Rooms

Some cities and counties in Idaho have laws that require wedding vendors to provide services for same-sex weddings. If they refuse, they could face fines or other penalties. Do you think Idaho should protect photographers, cake artists, and event planners who don't want to participate in same-sex weddings because of their religious beliefs?

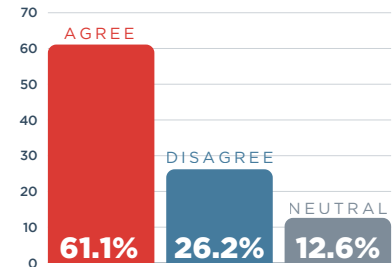

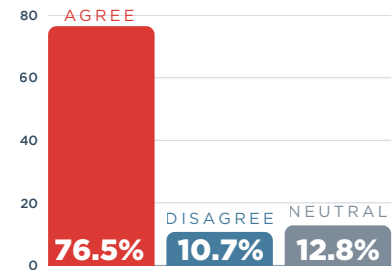
## Preventing Oregon-Style Drug Policies Through Constitutional Amendment

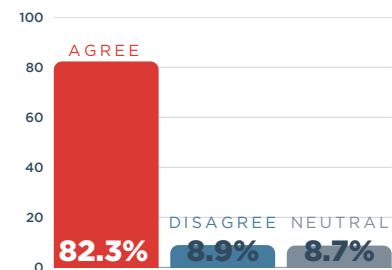
## Disabling Addictive Social Media Features for Teen Accounts

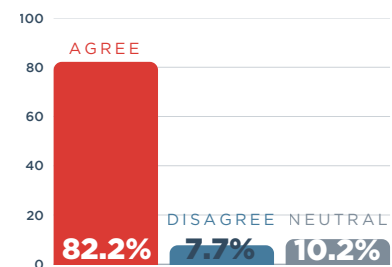
## Requiring Parental Consent for Children's App Downloads

Idaho has provided a nonrefundable child tax credit to help working families. But without legislative action, the child tax credit is set to expire at the end of this year — meaning that most families will see their state income taxes increase. Should the Idaho Legislature extend the child tax credit?



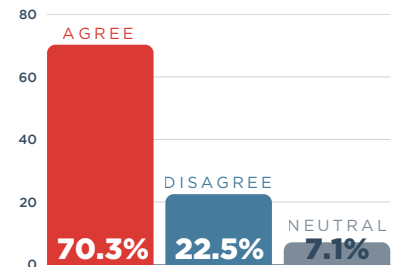

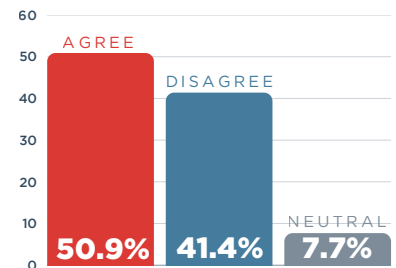
### Disclosing the Use of Aborted Fetal Tissue in Product Development and Production
